There is very little money in the province yet we have gambling dens in Sun City, Mmabatho Palms and Rio in Klerksdorp. Proceeds from these instances should generate enough income for the province to enable us to do more with the additional funds that we generate from them.

It is an open secret that most of the triple storey school buildings spread in rural and urban areas of the erstwhile Bophuthatswana were built from proceeds from the gambling resorts. What happens to the money they churn out? Surely that has to belong to the province and should not be controlled by Pretoria.

Some armchair critics and cynics used to say that was artificial economy but we argue that people did not starve and were not jobless.

FIFA looked east, south and north but could not find suitable accommodation for Heads of Government and FIFA big heads except at Sun City. Nothing artificial about the magnificence of that place; the founding Fathers who had prophetic vision knew that a place like that would come handy in the twenty first century.
